Archons,

- **Grand Sire Archon-Elect Loren Douglass (Zeta).**

The finalist proposals were rank ordered after a series of exceptional interviews. Based on their proposal, final presentation, and feedback from the interview panel, Archon

Mitchell and Dentons were selected as the Fraternity's new counsel.
